26th Annual Convention & National Seminar on "Net Zero 2070 and Built Environment"

Indian Buildings Congress (IBC) was founded on 1st September 1992 and registered as a Society on 29th March 1993, with its headquarter at New Delhi. The vision of the organization is a built environment, which is affordable, aesthetic, environment friendly, cost effective & competitive technology driven Built Environment capable of meeting needs of the Indian masses. In order to meet its objectives, IBC is striving continuously to bring all professionals connected with built environment on a single platform so as to form collective opinion on subjects related to Building Industry and present for consideration of the Government. Over 6300 Individual Members and over 110 Institutional Members, both in the Public and Private Sector, are members of IBC.

THE CONVENTION : IBC will be holding its 26th Annual Convention & National Seminar at A.P. Shinde Symposium Hall, NASC Complex, ICAR, PUSA, New Delhi on 10-11 June, 2023. The Annual Convention, apart from conducting business like holding of AGM, Governing Council Meetings and appointment of Office-Bearers for ensuing term, will also include a Seminar on "Net Zero 2070 and Built Environment". Members of the IBC and professionals of Government Departments, Housing Boards, Development Authorities, Town & Country Planning Organisations, State PWDs, Teaching & Training Institutes, Technical Universities, Builders, Developers and all others interested in building management are cordially invited to participate.

OBJECTIVES OF THE SEMINAR : For survival of civilization, global warming and climate change have been the major issues during the last couple of decades. With residential and commercial buildings being the largest energy consumers, sources are getting depleted at much faster pace in the recent decades.

Earth's source of fossil fuel (Petroleum, Natural Gas and Coal) which is the major driver of Global economy is vanishing at a much rapid pace causing high damage to the climate. Power stations convert only 30-35% of the input energy into electricity. The rest is wasted as heat resulting into Global warming which is the cause of concern for health, well being and pollution besides increase in rate of ice melting and glaciers which has reduced the water flow in rivers and will ultimately affect the survival of civilization. The need of the hour is therefore to attain net zero emission by ensuring the amount of greenhouse gas emission being released into the atmosphere are equal to the amount being removed from it.

To take effective steps in this direction and to contain the climate change, at COP26, India pledged a target to achieve net zero by 2070. At COP27, India submitted its first long-term strategy (LTS) for Low Carbon Development. In the

LTS, India outlines sector specific action areas, targeting the power, industry, transport, building, and urban sectors. Reducing global carbon dioxide emission to net zero by 2070 calls for nothing less than a complete transformation in production, transportation and consumption of energy.

Building and Infrastructure sector is the major share-holder in energy consumption and major contributor of Global warming. To a large extent cities are our future. The way existing and entirely new cities shape their energy infrastructure, the degree to which they can use alternative fuels to power their operations will have a defining impact on our ability to move beyond fossil fuel over the coming decades. Cities will be the stage on which the transition to net zero is played out. Integrating renewable energy into urban infrastructure development will be crucial in providing access to affordable, reliable and sustainable energy for every city resident. Therefore the objectives of this seminar are to brainstorm on the measures for making the Built Environment a net Zero so that the planet remains sustainable for the better health of civilization.

The Seminar will make a 360 degree review of all aspects viz, Technical, Financial, Social, Political, Policies, Regulations and evolve the policies and guidelines, that if, followed will contribute immensely to achieve net zero in the Built Environment and infrastructure Sector by 2070. The discussions are therefore planned to be held on the following sub-themes including case studies:

- (i) Climate Sensitive Building Envelope and design Measures;
- (ii) Energy efficiency measures,
- (iii) Renewable energy measures,
- (iv) Auditing, Monitoring & Evaluation measures
- (v) Policy & Regulations including R&D

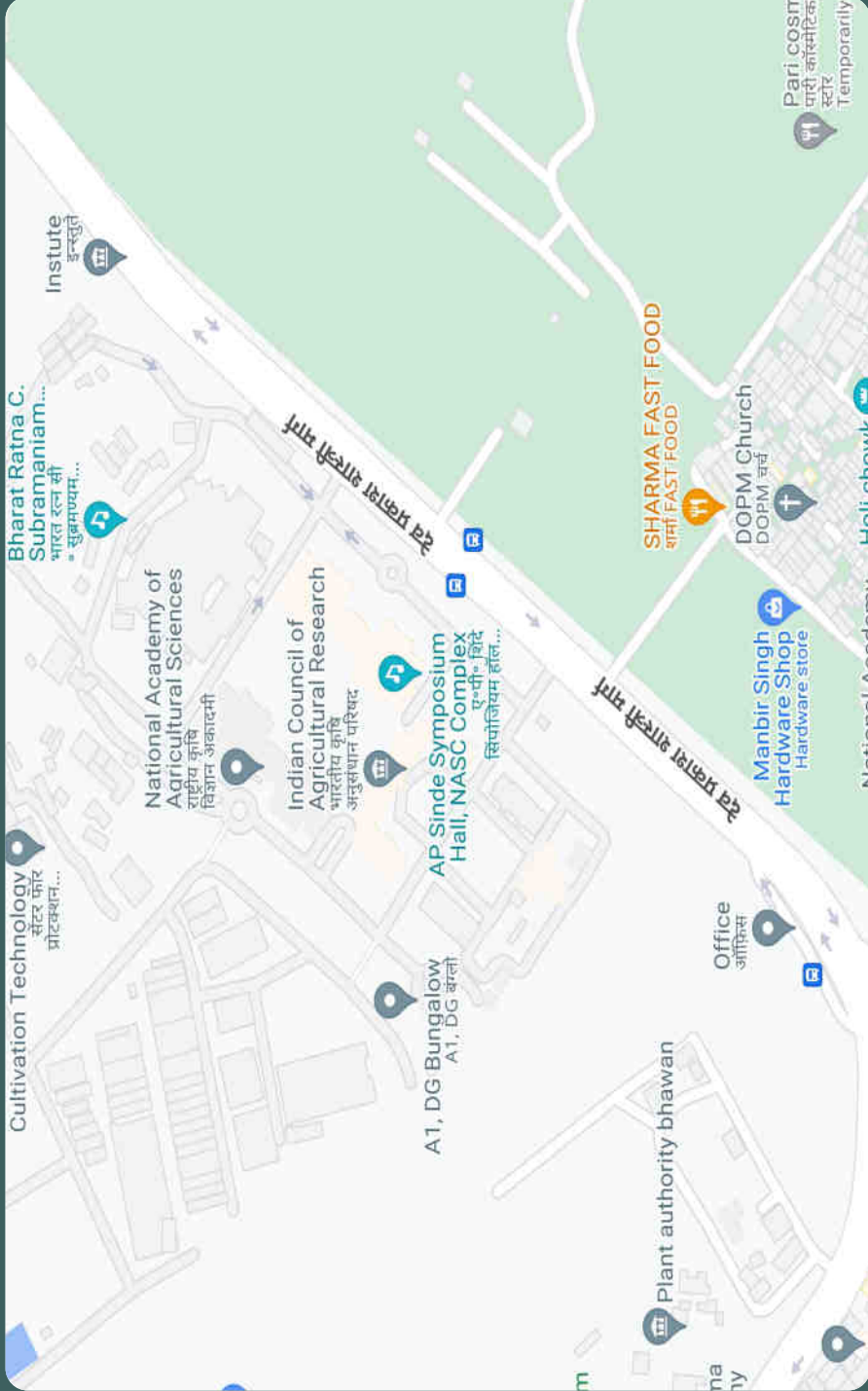
