Sub: Matters related to TA Rules & other provision as decided in GC meeting at Kochi on 1st Feb, 2026

The following matters related to TA Rules & others were approved in the 201st EC Meeting held on 02.11.2025 at Shimla & concurred in 112th Governing Council Meeting held at Kochi, Kerala on 1st February 2026:

The matter related to TA was discussed by the members during Nagpur programme and also in monthly Online discussion of EC & GC in October, 2025 when members opined to reduce the expenditure and also the matter related to Permanent invitees were discussed. During the discussion of TA Rule of IBC during 201st Shimla EC meeting, it was observed by the EC members that Permanent Invitee in the EC/GC is not covered by MoA of IBC. But, the members of IBC are requesting for considering them Permanent invitee & there are 5 request letters in this regard. There was communication by two EC members also in this regards who could not attend the EC meeting. After detailed discussion in the matter, the EC members present in Shimla meeting unanimously decided & approved that the provision of permanent invitee needs to be stopped/dropped as it is not in MoA of IBC. In connection with reducing expenditure & others, it was further approved in Kochi meeting as follows:

- The EC meeting will be held 4 nos instead of 6 nos.
- As per TA rule, the GC members elected/ Co-opted against 10.1.1.7, 10.1.1.9, 10.1.1.10 10.1.3.1-10.1.3.10, 10.4.2, will get TA for attending EC/GC meetings as entitled.
- Registration Fee @ Rs.500/- to be paid by GC/EC members for GC Meetings/Midterm Session/Annual Convention.
- EC members to book their Air ticket at least 15 days before the meeting date. If it is booked within 15 days, than 10% less payment will be made from booked amount.
- EC/GC members are to submit TA bill as per format within 15 (fifteen) days from the journey date. If it is submitted beyond this & if there is sufficient reasons for delay, President in consultation with EC will take decision.
- Past Presidents will be invited for attending EC, GC & Midterm Session & Annual Convention. They will get free Accommodation & other facilities in venue. No TA will be given.
- During Annual Convention/ AGM, No TA will be given to GC/EC members.
- As there is involvement of fund for TA, All EC & GC members have been requested to collect advertisement Rs.50,000/- & Rs.30,000/-respectively for the Built Environment.
- President, Founder President, Hony. Secretary, Past Presidents, Executive Director will be allotted independent room. Their Spouses who accompany shall be registered by paying Rs 500/-
- All other EC/GC members will get sharing rooms. If any of the member desires an independent room, the member has to pay the balance 50% of room rent.
- Their Spouses who accompany shall be registered by paying Rs 500/-and 50% of the room rent shall be paid by the member for Spouses.

This is circulated as approved in the GC meeting at Kochi on 1st Feb, 2026.
