**Item No. 1 To consider for enrolment of Shri Vijay Kumar Choudhary, Chief General Manager (Finance) NBCC (I) Limited as Individual Life Member of IBC**

**Item No.3 To consider alteration of Memorandum of Association Rule 10.2 for appointment of Hony Treasurer of IBC**

As per Rules 10.2 MoA of IBC for appointment of Hony Treasurer following amendments are proposed:

<b>Existing as per Rule 10.2</b>	<b>Amendment Proposed in Rule 10.2</b>
The Governing Council shall appoint a Honorary Treasurer from among the members at rules 9.1.1.1 to 9.1.1.5 & 9.1.1.11, an officer not below the rank of Chief Engineer of the Government of India or an officer equivalent rank who must be a member of Governing Council and belonging to the organizations represented by above members	The Governing Council shall appoint a Honorary Treasurer from among the members at rules 9.1.1.1 to 9.1.1.5 & 9.1.1.11, an officer not below the rank of Chief Engineer of the Government of India or an officer equivalent rank <b>or Chief General Manager of NBCC (I) Limited</b> who must be a member of Governing Council and belonging to the organizations represented by above members

Regarding alteration of Memorandum of Association of IBC Rule 16 provides as under:-

- “16.1 These rules and regulations shall not be altered, extended or abridged without the approval of at least two –thirds of those present in person at a meeting of the Governing Council and at least thirty days’ notice shall have been given of such meeting and of any proposal to alter, extend or abridge these Rules and Regulations.
- 16.2 In the event of differences of opinion arising as to the interpretation of the Rules and Regulations, the decision of the Governing Council shall be final and binding”.

In view of emergent situation the item is placed for consideration and **in principle approval of GC Members** through circulation. However, it will be placed in the next Governing Council meeting for ratification.

**Item No.4 To consider Appointment of Shri Vijay Kumar Choudhary, CGM, NBCC (I) Ltd. as Hony. Treasurer**

Shri Pankaj Tyagi was appointed as Hony Treasurer, IBC for the year 2023-24 in 104th GC meeting held on 11.06.2023. He vide his email dated 04.07.2023, has informed that due to some commitments and engagements, he is not willing to accept the offer to become Hony, Treasurer of IBC. Therefore another officer is required to be appointed for Treasurer.

During the 1<sup>st</sup> EC meeting held on 28.07.2023, the matter for appointing Hony Treasurer of IBC was discussed in detail. The name of Shri Vijay Kumar Choudhary, CGM, NBCC (I) Ltd. for the post of Honorary Treasurer in IBC was proposed by Shri K.K. Kapila, Past President, IBC and agreed by the EC subject to fulfillment of his eligibility.

In view of proposed alternation / amendment rule 10.2 of Memorandum of Association, IBC, he will become eligible for the appointment as Hony. Treasurer.

GC may consider and appoint Shri Vijay Kumar Choudhary, CGM, NBCC (I) Ltd. for the post of Hony Treasurer for the year 2023-24 replacing Shri Pankaj Tyagi.

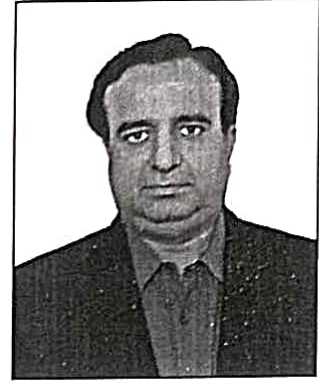
